# Artist Commission Call Out West Mercia Youth Justice Centre

## Deadline: Monday 10 March 2025, 5pm

## Introduction

In partnership with Severn Arts, and funded by Worcestershire County Council, West Mercia Youth Justice Service is commissioning a visual artist to work with a group of approximately 5 to 8 young people identified by the service to transform an outdoor and an indoor wall of the Tolladine Road Youth Justice Centre, Worcester.

This brief outlines the requirements of the project and gives details of an open day which will be held on Friday 21 February 2025 where artists and arts organisations can view the walls and surrounding space. It will also be an opportunity to meet representatives from Severn Arts and the Youth Justice Service as well as some participants, to find out more about the process and expectations of the commission before applying.

## The Importance of Enhancing the Space

Young people coming to the Tolladine Road centre have told the service that the building "looks like a prison", "is unfriendly" and "makes you feel sad and bad". As part of West Mercia Youth Justice Service's child-first approach, the service listens to feedback from young people and seeks to do something about it; publishing this through a "You Said, We Did" approach.

This project therefore aims to give these young people a voice and the power to be directly involved in making their space feel welcoming, relevant and appropriate, where they can rehabilitate successfully.

Some initial consultation has taken place about the current space and some thoughts about the new space. Here are some comments from the young people:



## The Brief



We are seeking an artist/organisation with an inspiring and inclusive approach, to work with a group of approximately 5 to 8 young people identified by West Mercia Youth Justice Service to co-design two new artworks for an indoor and an outdoor wall at Tolladine Road Youth Justice Centre. The selected artist/organisation will have a strong track record of excellent engagement with young people, experience of working with young people in challenging life circumstances, and an understanding of youth voice and co-creation.

They will aim to transform the space into a welcoming and personalised environment for its users. This will involve facilitating engaging workshops that will enable the project participants to develop their ideas for the artwork. It will also mean working with them to transform the walls using paint or whatever medium is decided collaboratively.

## Specification

This exciting opportunity involves the transformation of two walls at the West Mercia Youth Justice Centre on Tolladine Road, Worcester. The indoor wall is part of the communal space where young people meet with their support workers. The wall is currently painted white/grey and is 5.40m wide and 2.67m high. The outdoor wall is visible upon entry to the building, is currently bare brown/grey brick and measures 8.58m wide and 3.20m high.



The artwork must stay within the designated boundaries, must not include any inappropriate or political narrative and must be reflective of the ideas developed with the young people. The final design will be cocreated with participants and must also be approved by West Mercia Youth Justice Service and Severn Arts.





We are looking for artwork that creates a welcoming environment that supports young people's rehabilitation.

Proposals should demonstrate a clear vision and strong understanding of the site, its surroundings and the young people that will see it. Medium and materials used must be weatherproof, durable and low maintenance. The project will take place in an operational area and therefore careful consideration will be needed as to how the artwork will be created.

Please note, we expect the successful artist/organisation to provide a method statement and risk assessment before starting work and plans must comply with the Management of H&S at Work Regulations 1999. We also expect artists to have an up-to-date Enhanced DBS certificate or be willing to undertake the required DBS check.

#### The Commission Fee

The fee for this commission is £5,000 inclusive of workshops, planning, design and creation of final artwork, all materials, travel expenses and any equipment needed.

## How to Make an Application

Please send your proposal by **Monday 10 March 2025**, **5pm** (any submissions after this time will not be considered).

Please note that the shortlisting and interview process will be led by the young people involved in this project, and they have requested that applications are made in **video** form. Please submit your video application via <u>WeTransfer</u> to <u>recruitment@severnarts.org.uk</u> or via WhatsApp on 07776 530 562. If you are unable to send a video, please send a short written application.

Your proposal should include:

- A little about you and any relevant experience of delivering similar projects
- A selection of images or a link to a website or social media account where we can see examples of previous work
- Some initial ideas or concepts
- Your approach to inclusively engaging with young people
- Your proposed timetable for delivering the project
- Materials you might use
- Installation requirements
- A brief breakdown of how you intend to spend the budget
- Confirmation that you will be prepared to complete a method statement and risk assessment before starting work
- Contact details of at least one referee that will be taken up for successful artist

We welcome applications from individual artists, arts organisations and collectives.

#### **About West Mercia Youth Justice Service**

West Mercia Youth Justice Service (WMYJS) works with young people aged 10 – 17 years old who have got into trouble with the police or are at risk of getting into trouble with the police. It is partnership between the Local Authorities, National Probation Service, West Mercia Police, NHS organisations across West Mercia and the Office for the West Mercia Police and Crime Commissioner. The also work with housing and children's services, schools and education authorities, charities and the local community.

The youth offending team gets involved if a young person gets into trouble with the police or is arrested, is charged with a crime and has to go to court, or is convicted of a crime and given a sentence. They look into the background of a young person and try to help them stay away from crime. When they first come into contact with a young person they carry out an assessment to find out what happened and how they can support them. The aim of the assessment is to identify strengths, needs and problems, so that an intervention plan can be made to support a young person stay out of trouble in the future.
